WOC Collaborates with Duke University to Advance the “Future of Our Ocean” Series, with the First Session on 14 January “Mapping Our Oceans”

The first edition will focus on “Mapping Our Oceans: The Role of Science and Technology in Sustaining Ocean Ecosystems”.

The webinar features Dr. Patrick Halpin (Professor of Marine Geospatial Ecology, Marine Science and Conservation Division, Nicholas School of the Environment). He will be joined by Dr. Guillermo Ortuno Crespo, Stockholm Resiliency Center and Gabrielle Carmine, Duke University

New geospatial technologies are playing a crucial role in addressing many ocean challenges, including marine ecology, resource management, and ocean conservation. This webinar will describe current developments in geospatial ocean science and technology, and how they are being used to support ocean health and sustainable use. These advances are also informing new ocean governance structures, including the new implementation agreement for the Law of the Sea as well as helping to set priorities for the coming UN Decade of Ocean Science for Sustainable Development.

These issues are core to WOC programs and efforts and were addressed in the recent 7th WOC Sustainable Ocean Summit (SOS). The SOS 2020 report is available [here](#).
