FINANCING THE BLUE ECONOMY: WOC AND EUROPEAN MARITIME DAYS WORKSHOP

World Ocean Council and EU BlueInvest Platform Continue to Collaborate to Advance Financing for Ocean Sustainable Development

20 May 2021

European Maritime Days 2021 includes a special workshop on "Financing a Sustainable Blue Economy: From Pipe Dream to Pipeline", 21 May, 14:00-16:00 CET. The workshop features a panel discussion on the state of green/blue financing in the context of the EU Green Deal.

WOC CEO, Paul Holthus, will address "Towards a Common ESG Framework for the Ocean – Why This is Important for Investors" – which refers to efforts of the WOC Task Team of investment community representatives to develop an Ocean ESG/Impact Investing Framework (i.e. impact categories, metrics, indicators, reporting).

The WOC Ocean ESG/Impact Investing Framework Task Team has emerged from the ongoing WOC Ocean Investment Platform, especially the monthly Ocean Investor Roundtable which has been steadily developing a Blue Finance global community of practice since early 2020.

The European Maritime Days 2021 workshop also will showcase three EU blue project pipelines, and founders of two innovative projects shall present possible market paths for marine litter solutions. A virtual idea canvas is open for viewers to post their own ideas, initiatives and feedback on activities to boost investment on green transition and green recovery for the blue economy.

Outcomes from the workshop will feed into the BlueInvest platform, within its mission to boost innovation and investment in technologies for a sustainable blue economy, by supporting readiness and access to finance for early-stage businesses, SMEs and scale-ups.
